

MEMORANDUM OF UNDERSTANDING
between
HALLYM UNIVERSITY, REPUBLIC OF KOREA
and
UNIVERSITÀ DEGLI STUDI DI NAPOLI "L'ORIENTALE"

Hallym University, Republic of Korea, hereinafter referred to as HU, and *Università di Napoli "l'Orientale"*, hereinafter referred to as *Unior*, in recognition of their common interest in promoting mutual cooperation in the area of education and research, wish to expand the basis for friendship and co-operative educational exchange and have thus set forth the following Memorandum of Understanding.

ARTICLE I: PURPOSE

The purpose of this Memorandum of Understanding is to develop academic and educational co-operation on the basis of equality and reciprocity and to promote relations and mutual understanding between both universities.

ARTICLE II: SCOPE OF ACTIVITIES

Both universities undertake to promote and develop academic co-operation in the following ways:

1. Co-sponsoring of international conferences.
2. Exchange of academic staff, including course instruction relevant to their research area.
3. Exchange of students, who will be accorded educational credit from their study at host institution. Each student shall pay tuition and other required fees to home institution and will be exempted from payment of tuition and other required fees at visiting institution.
4. Co-operation in research and the presentation of its results.
5. Exchange of academic materials, publications and other scientific information.
6. Other educational and academic exchanges to which both universities agree.

ARTICLE III: FINANCIAL ARRANGEMENTS

7. Both universities agree that all specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds.
8. Both universities agree to seek financial support from national and international organizations for the cooperative activities to be undertaken as stated under the terms of this Memorandum of Understanding.

ARTICLE IV: AGREEMENT OF IMPLEMENTATION

A detailed description of the scope of activities shall be defined in an Agreement of Implementation, which constitutes an integral part of this Memorandum of Understanding.

An Agreement of Implementation will include such items as:

9. Elaboration of the responsibilities of each institution for the agreed upon activity.
10. Schedules for the specific activity.
11. Budgets and sources of financing for each activity.
12. Any other items deemed necessary for the efficient management of the activity.

ARTICLE V: INTELLECTUAL PROPERTY RIGHTS AND PUBLICATION

13. HU and the *Unior* will share all data and research findings, as well as patent rights, copyrights, and other intellectual property rights to any discoveries, inventions and products resulting from this Memorandum of Understanding.
14. Both parties must give written approval for the utilization and publication of the data and research findings.
15. Detailed management of the intellectual property rights and publication shall be defined in the Agreement of Implementation of each activity.

ARTICLE VI: SETTLEMENT OF DIFFERENCES

Any differing viewpoints and interpretations of this Memorandum of Understanding shall be settled amicably through mutual consultation or negotiation.


ARTICLE VII: AMENDMENTS, DURATION AND TERMINATION

16. Amendments to this Memorandum of Understanding can only be written under the mutual consent of the two parties.
17. This Memorandum of Understanding shall be in effect from the date of its signing and be valid for the duration of 5 (five) years from that date, and will be automatically renewed on an annual basis thereafter, unless terminated or replaced with a new Memorandum of Understanding.
18. This Memorandum of Understanding may be terminated by either party via a written notice given at least 6 (six) months in advance. In case the Memorandum of Understanding ceases to be in effect on account of termination thereof, the provisions of the Plan of Operation shall continue to be applied to the extent necessary to secure the implementation of existing activities as agreed upon in the Agreement of Implementation.

This Memorandum of Understanding is authentic. As witness to their consent to this

Memorandum of Understanding, the appropriate authorities hereunto provide their signatures.



STUDENT EXCHANGE AGREEMENT
between
UNIVERSITÀ DEGLI STUDI DI NAPOLI "L'ORIENTALE", ITALY
and
HALLYM UNIVERSITY, REPUBLIC OF KOREA

In the interests of expanding educational opportunities and promoting international understanding, Hallym University, Republic of Korea (HU hereinafter), and Università degli Studi di Napoli "L'Orientale", Italy (UNIOR hereinafter), agree to facilitate the educational exchange of students.

1) **Duration of Exchanges**

Each institution agrees to exchange individual students for a semester or an academic year, ideally on a one-for-one basis.

2) **Number of Students to be Exchanged**

Each institution may send up to two students each year for a full year. The number of students to be exchanged may vary as determined by mutual written agreement between the two institutions. Students will be accepted by each host institution by mutually agreed upon dates.

※ *Unior does not have a single campus, but its buildings are all in the center of Naples.*

3) **Student Program Fees/Benefits at Host Institution**

Each designated exchange student will pay his/her regular tuition and mandatory fees (not including health insurance) to the home institution and will receive these benefits from the host institution. The host institution agrees to place the exchange student in its residence halls during the normal semester or term period at the exchange student's expense.

※ *Unior doesn't have a residence hall for exchange students. The international office may help students in finding an accommodation in Naples. All accommodation fees are at the exchange student's expense.*

All travel costs will be the responsibility of the individual students. Miscellaneous fees such as special course fees, key deposits, books, etc., will be paid directly by each student participant.

4) **Insurance**

Each participant will pay for his/her own health and accident insurance to ensure adequate coverage.

5) **Dependents**

The obligations of each institution under this agreement are limited to the exchange of students and do not extend to spouses or dependents. Expenses of accompanying spouses and dependents are the responsibility of the exchange student.

6) **Student Eligibility**

It is understood that both institutions will strive to designate only well-qualified individuals for participation in the program and that academic backgrounds as well as letters of recommendation will be provided to the host institution.

7) **Balancing the Exchange**

Parity in numbers of exchange students is the objective of the agreement. However, each party should be prepared to consider a disparity in any given semester or year during the period of the agreement. Any and all imbalances shall be resolved by the end of the period of agreement.

8) **Academic Status of Students**

Exchange students will remain enrolled as regular degree candidates at the home institution and will not be enrolled as candidates for degrees at the host institution except by special arrangement. Credits toward the student's degree are to be awarded by the home institution. Students are expected to maintain the equivalent of a full course load at the host institution. Students enrolled in the host institution will be subject to the same rules and regulations as local students.

9) **Exchange Supervisor**

Each party to the agreement will appoint an officer who will be responsible for the coordination and administration of the exchange, including counseling to assist exchange participants, as below:


10) Effective Date and Termination of Agreement

This agreement shall be in effect for a period of 5 (five) years from the date of signing. The agreement may be extended by mutual consent, in writing, of both institutions for a period beyond its original date of expiry. The party desiring the extension will give a written notice of its intention to so extend the term of the Agreement at least ninety (90) calendar days prior to the end of the then-current term. Either party may terminate this agreement at any time by serving a written notice to the other party. Such termination will take effect six months from the date of that written notice.

Any student whose agreed upon program of study extends beyond the termination date proposed shall be allowed to complete his or her program of study.


11) Legal Indemnities and Policies

1. No monetary consideration will be exchanged between the two institutions, nor will there be any indemnities, reimbursements for expenses, or sharing of fees or profits arising from the exchange, except in cases where UNIOR or HU is agreeing to pay the tuition and/or fees of the students.
2. The relationship of the host institution and the home institution under this agreement shall be that of independent contractors, and a party shall not be deemed, nor hold itself out as being, a partner or agent of the other party. Neither host institution nor home institution shall be liable for acts of the other, nor shall they be liable for the acts of students participating in the exchange.
3. Both institutions subscribe to a policy of equal opportunity and will not discriminate on the basis of race, color, gender, age, height, weight, marital or familial status, ethnicity, religion, national origin, sexual orientation, gender identity or disability.
