#### AGREEMENT BETWEEN

# UNIVERSITY OF NAPLES L'ORIENTALE (NAPLES, Italy)

#### AND

# JSC «CENTER FOR INTERNATIONAL PROGRAMS» (ASTANA, Kazakhstan)

The University of Naples L'Orientale, hereinafter referred to as «University» duly represented by the Rector Prof. Elda Morlicchio residing in Italy, 80121 Naples, Palazzo Du Mesnil, Via Partenope 10/A and JSC «Center for International Programs», hereinafter referred to as «CIP», represented by the President Mr. Zhanbolat Meldeshov, residing in 010000, 8 Mangilik El., Astana, Republic of Kazakhstan, hereinafter collectively referred to as the Parties, have concluded this Agreement (hereinafter referred to as «Agreement») regarding the following:

### 1. THE SUBJECT AND THE PURPOSE OF THE AGREEMENT

- 1.1. The purpose of this Agreement is an effective and constructive cooperation of the Parties in the development of international cooperation in the field of education.
- 1.2. In pursuance of this Agreement, the Parties have identified the following areas of mutual cooperation:
- exchange of experience in methods and technologies of development of educational processes;
- development of joint collective educational programs and projects.
- 1.3. Under this Agreement, University provides \_0 (zero)\_\_ scholarships on the published tuition fee for all students recommended by the CIP.

# 2. RIGHTS AND DUTIES OF THE PARTIES

#### 2.1. Duties of University:

- 2.1.1. to provide CIP with necessary and reliable information about educational programs abroad;
- 2.1.2. to provide information on the start and end dates of studying, its duration;
- 2.1.3. not to disclose confidential information obtained during the implementation of this Agreement.

## 2.2. Rights of University:

2.2.1.to request information about students admitted to study at University.

#### 2.3. Duties of CIP:

- 2.3.1. to conduct information work on the possibilities of getting an education in the University;
- 2.3.2. to provide University with all the necessary information concerning the education of students;
- 2.3.3. not to disclose confidential information obtained during the implementation of this Agreement.

## 2.4. Rights of CIP:

- 2.4.1. to address to University on the questions connected with passage of training by students;
- 2.4.2. to require the provision of University services provided by this Agreement and request other information relating to the education of students.

# 3. TERM OF ACTION, PROCEDURE FOR MODIFICATION AND TERMINATION OF THE AGREEMENT

- 3.1. This Agreement shall enter into force from the day of its conclusion and shall be valid for five years. The period of validity may be extended by mutual written agreement.
- 3.2. This Agreement may be terminated by agreement of the Parties in case of written notification by one of the Parties provided for 30 (thirty) calendar days.

3.3. Termination of this Agreement will not affect other relations of the Parties provided for by separate agreements.

#### 4. FORCE MAJEURE CIRCUMSTANCES

- 4.1. The Parties shall not be liable for full or partial non-fulfillment of their obligations under this Agreement, if such failure was a consequence of force majeure circumstances, namely: floods, other natural disasters, military actions, and decisions of public authorities or other events.
- 4.2. A certificate issued by the authorized body shall be a proper confirmation of the existence of force majeure circumstances and their duration for the Parties.

#### 5. SETTLEMENT OF DISPUTES

- 5.1. All disputes and disagreements that may arise between the Parties on issues that have not been resolved in the text of this Agreement will be resolved through negotiations.
- 5.2. The disputes that are not settled in the course of the negotiations are resolved taking into account the norms of international law.

#### 6. FINAL PROVISIONS

- 6.1. This Agreement is made in the English language in 2 copies. In the event of a dispute over the authenticity of the language, the Parties shall resolve the dispute by negotiation and amendment.
- 6.2. Any changes and amendments to this Agreement are valid if they are made in writing and signed by duly authorized representatives of the Parties.
