MEMORANDUM of UNDERSTANDING (M.O.U)

On

Educational, Research and Technological Cooperation

Between

Kharazmi University (I.R of Iran)

And

UNIVERSITA' DEGLI STUDI DI NAPOLI "L'ORIENTALE"(Italy)

Kharazmi University of Tehran, located in No.43, Shahid Mofatteh Ave.,15719-14911,Tehran,I.R of Iran, represented by its Chancellor, Prof. Mohammad-Ali Sobhanollahi, on the one part and Università degli Studi di Napoli "L'Orientale" (hereinafter L'Orientale) represented by the Rector Prof. Elda Morlicchio, Via Chiatamone, 62, Naples L'Orientale) hereinafter referred on the other part, with the aim of developing and expanding the educational, research and technological cooperation between the two countries, have agreed upon the followings:

Article 1

PURPOSE OF THE AGREEMENT

The purpose of the agreement is to establish cooperative relations between L'Orientale and Kharazmi University in areas described as follows:

Article 2

SCOPE OF THE COOPERATION

Both parties agree to establish academic cooperative projects that are of mutual interest to colleges, schools, institutions and departments of both parties. These projects may be continued and renewed by mutual consent. This M.o.U will have from time to time annexes attached to it with regard to specific programmes

Article 3

GENERAL AREAS OF THE COOPERATION

The parties intend to promote the following exchange activities based on their respective academic and educational needs:

3. 1 Exchange of faculty and scholars (professors, lecturers, or researchers.)
3. 2 Exchange of students (including undergraduate and graduate students).
3. 3 Exchange of academic information and materials.
3. 4 Exchange of periodical academic publications.
3. 5 Organization of joint research programs.
3. 6 Organization of joint conferences.
3. 7 Exchange of university personnel.
3. 8 Other academic exchanges agreed upon by both parties.

Specific details relating to a particular program are given in the associated annexes.

Article 1

PURPOSE OF THE AGREEMENT

Article 2

Article 4

FINANCIAL ARRANGEMENTS

As a general principle, the costs of co-operative activities undertaken pursuant to this M.o.U will be funded on a mutually agreeable basis.

Article 5

CONSULTATION

Representatives of the Parties will convene by mutual agreement to review the operation of this M.o.U.

Article 6

SETTLEMENT OF DISPUTES

Any dispute arising from the interpretation of implementation of this M.o.U will be resolved by consultation between the Parties

Article 7

IMPLEMENTATION

7.1 Each Party will facilitate the arrangement of other activities in its territory not specifically mentioned in this M.o.U which are in accordance with the spirit of this M.o.U


7.2 Each Party shall assign their own contact coordinator for developing and implementing specific programs.

VALIDITY

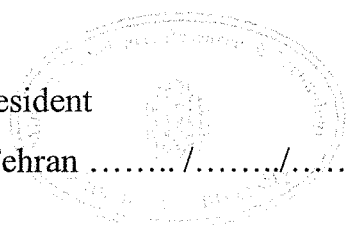
