

**AGREEMENT ON ACADEMIC EXCHANGE
BETWEEN
UNIVERSITY OF NAPLES "L' ORIENTALE"
AND
UNIVERSITY OF FUKUI**

1. University of Naples "L' Orientale" and University of Fukui, desiring for academic and research exchange and facilitation thereof, agree on the following matters:
 - (1) Mutual visits of researchers
 - (2) Mutual enrollment of students who are eligible as international students
 - (3) Promotion of mutual cooperation by researchers of both institutions such as joint research in fields of mutual interest
 - (4) Exchange of academic materials, publications, and information
2. Both institutions acknowledge that the visitors shall comply with regulations of each country such as immigration rules and with those of the host institution such as rules on admission and work regulations.
3. Both institutions agree that visitors will be individually responsible for those travel and accommodation expenses that should exceed the financial support offered by their home institution, as well as such personal expenses as telephone charges, books, and local transport. Each visitor will be responsible for getting health insurance or personally covering medical expenses incurred during the stay at the host institution.
4. Both institutions acknowledge that the term of this Agreement shall be five (5) years since the day when it is signed by a representative of each institution and may be extended by mutual consent. In addition, this Agreement may be terminated if either institution gives a nine (9) months' written notice on the termination to the other institution.



MEMORANDUM ON STUDENT EXCHANGE
SUBJECT TO
THE AGREEMENT ON ACADEMIC EXCHANGE
BETWEEN
UNIVERSITY OF NAPLES "L' ORIENTALE"
AND
UNIVERSITY OF FUKUI

University of Naples "L' Orientale" and University of Fukui, agree to admit students mutually in accordance with the following conditions:

1. The status of the students admitted by either institution shall be "special research students" or "special auditing students with credits" of the host institution.
2. The duration of the exchange of each student shall be, in principle, one (1) semester or two (2) semesters, unless otherwise mutually agreed upon by both institutions, and the start of the duration should be, in principle, at the beginning of a new semester of the host institution.
3. The number of the exchange students from either institution shall be three (3) or less a year.
4. The host institution shall waive a fee of entrance examination, admission, and tuition to the exchange students.
5. Only highly motivated students of above-average academic quality will be selected to participate in an exchange program. Exchange students must meet both language proficiency and academic requirements of the host institution.
6. The student's home institution reserves the right to reevaluate his/her scholastic performance to meet the home institution's requirements, if necessary.
7. This Memorandum may be amended by mutual consultation and agreement if the need arises.
8. Issues not covered by this Memorandum shall be handled by mutual consultation and agreement.
9. This Memorandum shall come into effect immediately after it has been signed by a representative of each institution.
