**Agreement of Cooperation**  
Between  
**Cairo University and University of Naples "L'Orientale" (UNIOR)**

In the fields of Research, Education and Conferences.

Based on the executive programme of the already established cultural agreement between Egypt and Italy, the two parties, Cairo University and University of Naples "L'Orientale" (UNIOR), Italy have agreed on establishing direct cooperation between them in the fields of research, education and conferences of interest for the two parties, that enhance cultural understanding between the two countries. This is to be carried out according to what is mentioned in the following paragraphs of the agreement.

**First:**

The cooperation between the two undersigned parties takes the form of exchanging staff members and students, establishing common workshops and participating in research and academic publication, establishing a system of joint supervision of MAs and PhDs, teaching joint courses conducted through web-based digital video conferencing, etc.).

**Second:**

This agreement is not to be interpreted in a way that comes in contradiction to prior commitments on behalf of the two parties, or any of their affiliated organizations, that leads to the suspension of funding. Both universities acknowledge that the visit by students from one university to the other shall be subject to the entry and visa regulations of Egypt and Italy/the European Union and shall comply with the regulations and policies of Cairo University and UN.

**Third:**

The agreement is liable to amendments in the light of a written arrangement that comes upon the demand of either of the two parties. Any amendment comes into effect from the date of signing the agreement by the two parties.

**Fourth:**

The agreement takes effect for five years starting from the date of signing it, and is automatically renewed for the same period of time unless one of the parties demands in writing, and six months prior to the due date of the agreement, that it should not be

renewed. Upon termination, any project or exchange already underway, shall be continued to completion.

**Fifth:**



Both universities agree that all expenses, including research material, international and domestic travel, per diem, honoraria, and all other costs shall be the responsibility of the home university unless otherwise stated. Each side will do its utmost to make available university accommodation to visiting faculty and students.

The two universities are committed to the fulfillment of all that is mentioned in this agreement regarding the fields of cooperation.

**Sixth:**

Each party is committed to recruiting a coordinator for the agreement, who has to prepare the executive programmes related to the agreement, supervise the implementation of the agreement, and submit annual reports about it.

Each party signs two copies of the agreement in English and each keeps a copy to work in the light of this agreement.
