



Preamble

Catalan Institute of Human Paleoecology and Social Evolution (IPHES) and the University of Naples "L'Orientale", wishing to establish ties between the two Institutions and to develop cooperation in conducting research and training in the fields of study of human and social evolution agree as follows:

ART. 1

The Agreement is aimed at strengthening joint research and academic exchanges between the two Institutions in the fields of archaeology, geoarchaelogy, bioarchaelogy and archaeobotany.

ART. 2

In order to implement the agreement, in conformity with the availability of funds and to mutual consent, the two Partners agree to conduct:

- a) mutual exchange of Faculty members, junior staff members, researchers, and advanced students (graduate and postgraduate) involved in the fields of archaeology, geoarchaelogy, bioarchaelogy and archaeobotany
- b) joint research, seminars and academic meetings in the previously indicated fields;
- c) exchange of information, documentation and university publications.

ART.3

This Agreement does not constitute a financial commitment or obligation by either Partner. Financial terms and conditions of activities of the cooperative programs will be established on a mutual agreement. Efforts will be made by both Partners to secure funds for the implementation of the agreement.

ART. 4

Related to scientific publications, outreach and communication:

- a) The Parties agree to discuss and set upon appropriate scientific dissemination of the results, outreach actions and the promotion of the activities undertaken collaboratively under this MOU.
- b) Any use by one Party of the name or logo of the other Party or the other Party's related organisations must be in accordance with the other Party's policies and approval processes or otherwise in accordance with a written agreement between the Parties.
- c) Prior to commencing any collaborative activity, each of the Parties will inform participants of any applicable policies relating to intellectual property created by the participants. The participants shall confirm in writing their understanding and agreement with these policies.

ART.5

The Rector of the University of Naples "L'Orientale" and the Director of the Catalan Institute of Human Paleoecology and Social Evolution (IPHES) are responsible for implementing the agreement

ART.6

This Agreement will be effective beginning on the late date of the official signature by the two Partners, and will be operative for five years. The agreement may be renewed by mutual consent. Both Institutions have the right to terminate this agreement with a six months written notice to the other Partner.

In case of controversy over the interpretation or the enforcing of the present agreement, the two Institutions will appoint an arbitation committee composed of one member appointed by each part and a third one who will be jointly appointed.
