

AGREEMENT between

1.0 PURPOSE

The purpose of this agreement is to develop scientific cooperation on the basis of equality and reciprocity and to promote sustainable partnership and mutual understanding between the *Institute of Archaeology of the Czech Academy of Sciences, Prague* in *Czech Republic* and the *Università di Napoli "L' Orientale"* in *Naples, Italy*. Both may be referred to individually as the "party" or collectively as the "parties".

2.0 SCOPE OF ACTIVITIES

Institute of Archaeology of the Czech Academy of Sciences, Prague and *Università di Napoli "L' Orientale", Department of Asian, African and Mediterranean Studies*, aim to establish and undertake cooperation with, in areas that may include, but are not restricted to, the following activities:

- Joint research activities and scientific collaboration on the field of environmental archaeology, archaeometry and related disciplines
- Student and postdoctoral fellow exchange between the parties
- Organization and participation in seminars, workshops and conferences
- Short term academic exchange
- Exchange of research and education materials, publications and academic information

3.0 ACTIVITY IMPLEMENTATION

The Parties pursue the cooperation mentioned in section 2.0 through the following means:

- Research on methods of dating of archaeological material and their combinations
- Publication of joint scientific papers, books and studies
- Participation on research activities (e.g. research projects and expeditions)
- Dissemination of Arabian and African publications & researches in Italy & the Czech Republic
- Dissemination of European publications and researches in Arabia and Africa.


4.0 COORDINATION

Coordinator shall be named by each institution to serve as liaisons for implementing this agreement. All activities conducted under the auspices of this agreement must have the endorsement of the coordinators. Coordinators shall notify their counterparts should a new person be named to the position.

5.0 RENEWAL, TERMINATION AND AMENDMENT

- This agreement shall remain in force for a period of seven years from the date of last signature. Agreement may be extended by the written consent of the parties.
- This agreement may be terminated by either party by giving notice to the other party at least 180 days in advance of the stated termination day.
- Termination of this agreement shall not affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed to by the parties in writing.
- This agreement may be amended only by the written consent of the parties.



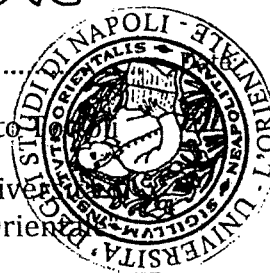
