Premise

The Università degli Studi di Napoli "l'Orientale" and the *Department of Political Science and International Relations*, at the University "Sarajevo School of Science and Technology" (SSST) of Sarajevo seeking to establish and develop institutional ties and, in particular, **to develop co-operation in post-graduate teaching and research programmes and to further activities in the fields of international relations, human rights and peace building/conflict resolution**

Art.1

The scope of the Agreement is:

- to develop joint projects between the two institutions ;
- to co-operate in the development of **interdisciplinary studies in the context of institution building, good governance, EU socio-political instruments and human rights/non-discrimination within the two institutions;**
- **to promote the exchange and mutual development of the respective academic journals and publications in the above mentioned fields of research.**

Art.2

In order to implement the above mentioned objectives, subject to the availability of funds and to mutual consent, the two Parties agree to conduct joint collaborative programmes in the following fields:

- mutual exchange of Faculty members, junior staff, researchers and post-graduate students involved in research activities carried out in the respective institutions;
- participation in, and organisation of, joint research seminars, conferences and academic meetings;
- exchange of academic material, information, documentation and university publications;
- Development and submission of joint project proposals (when applicable)

Art.3

Financial terms and conditions of activities for the co-operation programmes will be established by mutual agreement. Efforts will be made by both parties to secure funding for the implementation of such programmes. Both parties agree about informing each other about call for proposals for projects that could be jointly presented

Art.4

The Rector of the Università degli Studi di Napoli "L'Orientale" and SSST are responsible for the enforcing of the present Agreement, subject to approval by Higher Authorities as required by Law.

Art.5

This Agreement will take effect subsequent to the signing by the two Parties and from the dating of the completed signatures. It will remain in force for three (3) years. After the initial period it may be renewed by mutual consent. Either Party reserves the right to terminate this Agreement upon six (6) months written notice to the other. Upon termination, any project or exchange already under way shall be continued to completion.


Art.6

In case of controversy over the interpretation or the enforcing of the present Agreement, the two Parties will appoint an arbitration committee composed of one member designated by each Party and a third member who will be jointly selected.
