

**Memorandum of Understanding
Between
Department of French and Italian at the University of California, Santa Barbara
and
Università di Napoli "L'Orientale", Italy**

This Memorandum of Understanding (MOU) is entered into by and between The Regents of the University of California, on behalf of Department of French and Italian at the University of California, Santa Barbara (UCSB), the Università di Napoli "L'Orientale".

Scope

UCSB and Università di Napoli "L'Orientale" agree that fundamental research collaboration would be mutually beneficial. The areas of cooperation, subject to mutual consent and approval, include any desirable and feasible activity to further exchanges of faculty, research/postdoctoral scholars, and graduate students. Such interaction may include joint conferences and special short term projects.

The parties may enter into specific written agreements hereunder to clarify and define the nature, extent and terms of the proposed collaborations. Prior to entering into any such agreements, these agreements will require the approval of appropriate officers from each institution. For agreed upon activities, both institutions will make available their facilities and staffs as further defined in such agreements.
