The Rectors of the two universities agree to implement a formal agreement with the following contents:

Article 1 - Scientific staff

To facilitate the exchange of scholars on informal or professional visit and exchange of visiting professors for teaching and research with respect to procedures established within each institution

Article 2 - Exchange of students

To provide access to higher education for qualified students, planning to pursue their graduate and post-graduate programs at each institution in the areas of Language, Literature and Cultural Studies, at first. Agreement to this end will initially be considered on a case by case basis subject to availability of facilities and funding. Foreign students, however, can be enrolled at host university without being asked for further fees and are eligible to apply to all Universities' programs for scholarship and fellowship support and tuition waivers.

Article 3 - Joint research projects

To promote advancement of science, technology and various fields of human learning through the understanding of co-operative research on topics of mutual interest and expertise and to stimulate contacts between researchers and groups.

Article 4 - Exchange of scientific materials

To exchange as widely as practicable such items as scientific and scholarly publications, documents and materials as well as university calendars, perspectives, text book course outlines, reference material, journals and data bases.

Article 5 - Exchange of information

To provide information of substantive programs of education and research, to entertain invited guests and delegations, participating in conferences, seminars on topic of mutual interest and to encourage and strengthen communication and co-operation between members of the two institutes.

Article 6 - University personnel visits

To establish linkages between the two institutions which shall serve as a framework for further cooperation to exchange scientific information and develop scientific co-operative projects and programs. Arrangement for such visits will be made under the aegis of the two institutions. Purpose, timing and other details regarding exchanges and short visits will be provided to the host institution at least three months prior to proposed visit, if at all possible.

Article 7 - Grant of joint degrees

To grant joint degrees to non-resident post graduate students, who complete their degree requirements under the direct supervision of the home Institution, co-tutored by the host institution

Article 8 - Awarding scholarship

To award scholarships to non Ph.D and Ph.D students and Faculty staff of one Institution, dispatched to the partner Institution to study for higher degree at the host Institution, in which the Ph. D students may participate in seminars and be advised by scholars of the host Institution, thereby making it pertinent for either co-supervision to be present during a candidate's final examination in his/her home university.

Article 9 - Funding of co-operative projects of programs

Before any particular co-operative projects of program is initiated, all financial details shall be negotiated and agreed upon by the two institutions, with each partner acting within the scope of resources specifically allocated by administrative authorities. Co-operative projects requiring financial support shall not be initiated in the expectation of support by either institution.

Article 10 - Program planning

To facilitate program planning, attempts will be made to hold biannual meetings between representatives of the two institutions. The purpose of such meetings will be to develop close contacts and understanding of the needs and priorities of the two institutions and to establish as much as possible the framework of co-operative programming.

Article 11 - Financial engagement

Each partner can host two students/teachers/staff per year for a maximum of two months each. Each sending institution will take care of the travel costs of its personnel to and from the hosting institution. Each receiving institution will take care of local travel costs (to and from the airport) and of cost for full boarding (food and accommodation) of foreign guests. Local costs for common research and publications are also eligible within the agreement.

Article 12 - Duration of agreement

The present agreement is valid for 5 years from the effective date of signing. Each party may terminate the agreement with six month's advance written notice to the other party. Such termination shall not affect the validity of any agreements already made under the terms of this agreement.


Article 13 - Regulation and law

In any condition, all the above mentioned articles should not be inconsistent with regulations and laws of Republic of Tanzania and Republic of Italy.

Article 14 - In case of discord

In case of misunderstandings, both sides will agree the cases to be referred and solved by a Board consisting of wise members of the two universities.

The present agreement is drawn up in two copies, both in English language


