**Extension agreement No. 2 between
École Normale Supérieure (ENS)
and
Università degli Studi di Napoli "L'Orientale"**

Between :

École Normale Supérieure,

A French Public Institute and Scientific, Cultural and Professional establishment

Having its registered office at 45, rue d'Ulm, 75005 PARIS

Represented by its Director, Mr. Marc MEZARD,

hereinafter referred to as "**ENS**"

And :

L'Università degli Studi di Napoli "L'Orientale",

Having its registered office at Via Chiatamone 61/62, 80121 NAPOLI

Represented by its Rector, prof. Roberto Tottoli,

hereinafter referred to as "**Università**"

ENS and Università are hereinafter referred to individually as "Party" or collectively as the "Parties".

Preamble :

The Parties have concluded a cooperation agreement (hereinafter referred to as the "Initial Agreement") signed on January 29, 2014 between the Centre for the Study and Edition of Texts (CESET), laboratory of the Università degli Studi di Napoli "L'Orientale", and the Institute of Modern Texts and Manuscripts (ITEM), UMR 8132 of the École Normale Supérieure, for a period of three years, in order to develop:-

- Research and research training,
- The synergy of networks and scientific resources,
- The dynamics of joint projects and the reciprocal exchange of students and researchers,
- Bilateral scientific transfers between France and Italy,
- Scientific cooperation in a European perspective.

The Initial Agreement was extended once for a period of three years and signed on March 26, 2017.

ARTICLE 1: PURPOSE OF THE EXTENSION AGREEMENT

The purpose of this Extension Agreement No. 2 is to extend the Initial Agreement for a period of three (3) years and to amend Article 5 titled "Terms of application" of the Initial Agreement.

ARTICLE 2: MODIFICATION OF THE TERMS OF APPLICATION

Article 5 of the Initial Agreement is modified as follows:-

"This framework agreement shall enter into force upon signature by both Parties. It will be valid until the end of the present Agreement and may be subject to occasional revisions or amendments by agreement of both Parties.

It may be terminated by either Party after three (3) months' notice. However, where appropriate, actions in progress will be carried out to their conclusion."

ARTICLE 3: MISCELLANEOUS PROVISIONS

This extension of agreement shall enter into force on the date of signature by both Parties and will be valid until December 31, 2023.

All other terms set forth in the Agreement shall remain unchanged and this Amendment and the Agreement shall be deemed a single integrated agreement for all purposes.
