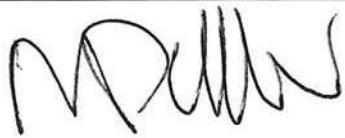


Extension of Agreement

MEMORANDUM OF UNDERSTANDING
BETWEEN
THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS, USA
AND
UNIVERSITÀ DEGLI STUDI DI NAPOLI "L' ORIENTALE"
IN
NAPLES, ITALY

The Board of Trustees of the University of Illinois, acting on behalf of its Urbana-Champaign campus, in Urbana, Illinois, U.S.A. ("ILLINOIS") and Università degli Studi di Napoli "L' Orientale", in Naples, Italy ("UNIOR"), wishing to establish cooperative relations between the parties through mutual assistance in the areas of education, research and others, agree as follows:

ARTICLE 1: SCOPE OF THE COLLABORATION

1.1 The areas of collaboration include activities or programs offered at either institution that will contribute to the fostering and development of the cooperative relationships between the two institutions.

1.2 Each Party may offer to the other Party opportunities for activities and programs, such as teaching, research, exchange of faculty and students, and staff development that will foster and develop the collaborative relationship.

ARTICLE 2: GENERAL AREAS OF COOPERATION

2.1 This MOU is not binding on either Party but is intended to facilitate discussions relative to, but not limited to, the general areas of cooperation specified herein. Collaborations implemented under this MOU shall be carried out, subject to availability of funds and the approval of the Board of Trustees of the University of Illinois and of the Rector of Università degli Studi di Napoli "L'Orientale", through such activities or programs as:

- 2.1.1 Joint educational, cultural, and research activities;
- 2.1.2 Exchange of faculty members for research, lectures, and discussions;
- 2.1.3 Exchange of advanced graduate and professional students for collaborative or independent research

NOTE: This MOU does not provide for the exchange of undergraduate or graduate students who propose to enroll in classes and earn academic credit at the host institution. The Parties will enter into a separate agreement, which shall stipulate details of credit transfer, fees and participant qualifications prior to initiating the exchange of students or the acceptance of applicants as international non-degree students at either institution.

- 2.1.4 Participation in seminars and academic meetings;
- 2.1.5 Exchange of academic materials, publications, and other information;

2.2 Prior to initiating any specific activity or program contemplated by this MOU, the Parties will negotiate and enter into a separate agreement, signed by the Parties' authorized representatives, that describes the terms of the arrangement, including the budgets. Each Party will designate a Liaison Officer to develop and coordinate specific activities or programs.

3 RENEWAL, TERMINATION AND AMENDMENT

This MOU shall remain in force for a period of five (5) years from the date of the last signature, with the understanding that it may be terminated by either Party providing sixty (60) days advance written notice to the other Party. The MOU may be extended or amended by mutual consent of the Parties, confirmed in a written amendment signed by an authorized representative of each Party.

4 GENERAL MATTERS

4.1 USE OF NAMES. Neither Party will use the name of the other in any form of advertising or publicity without the express written permission of the other Party. UNIOR must seek permission from ILLINOIS by submitting the proposed use, well in advance of any deadline, to the Associate Chancellor for Public Affairs, University of Illinois, Third Floor Swanlund Administration Building, 601 East John Street, Champaign, IL, 61820 USA; fax (217) 244-7124. ILLINOIS must seek permission from UNIOR by submitting the proposed use, well in advance of any deadline, to the Associate Chancellor for Public Affairs, University of "L'Orientale" Via Chiatamone 61/62, Naples, Italy.

4.1 NOTICES. Any notice to given under this MOU must be in writing and will be effective upon receipt evidenced by: (a) confirmed facsimile transmission; (b) return receipt of postage prepaid registered or certified mail; or (c) delivery confirmation by commercial overnight carrier. All communications will be sent to the addresses set forth below or to such other address designated by the Parties by written notice to the other:

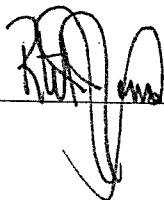

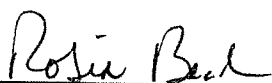
