My current book project examines Justice Thurgood Marshall's Indian law decisions through a law and humanities lens. It undertakes an archivally based "tribalography" to re-construct the legal arguments that Native peoples used to transform their social and political relations during the late 19th and early 20th century in order to tell the story of the relationship between law and social power from the perspective of tribal participants. It shows how tribal-activist writers responded to legal dispossession, manifesting the complexity of the tribal voice by drawing from civil rights, slave law, and literary sources. By aligning the voices of Native writers that preceded the self-determination era, a pivotal period in which tribal governments won back tribal sovereignty by using domestic legal systems, it shows how tribes engaged with intersecting, competing, and conflicting legal paths that deployed both tribal, civil rights, and human rights arguments. Close readings of texts by Sarah Winnemucca Hopkins, Francis LaFlesche, Susette LaFlesche, Charles Eastman, Luther Standing Bear, Linda Hogan, and Louise Erdrich demonstrate the capacity of literature to confront tribal removal and allotment

and to recast legal dispossession by restoring intra-tribal legal imaginaries. Foundational legal decisions decided by the Marshall court concretize the discursive struggles in which tribal identity, ethnicity, and gender were implicated in tribal sovereignty as a recognition of social power that, paradoxically, was formative of tribal autonomy yet impeded civil rights and literary-activist aims.

This collaborative research project documents Heiltsuk women's leadership in managing environmental crises, using the Nathan E. Stewart oil spill as a case study. It employs oral interviews by Heiltsuk community members to record how women contribute to the protection of Heiltsuk land, culture, identity, and traditional practice. The research is community-driven and community-responsible, including in its research design members from Heiltsuk Nation, with approval by the Nation's oversight research board, the Heiltsuk Integrated Research Management Department. The research has three objectives: to show how women protect the common good; to record how they provide strength to the community; and to analyze how they engage in decision-making and actions that sustain community members, protect family relations, and provide guidance through their strength and knowledge, grounded in Heiltsuk customs, traditions, and community practices.

The webinar included a live question and answer period and an in-person vigil for participants to share stories about how Indigenous women inspire them.
