



MEMORANDUM OF UNDERSTANDING between

UNIVERSITA' DEGLI STUDI DI NAPOLI "L'ORIENTALE"

A university in Italy, herein represented by Prof. Roberto Tottoli in his capacity as Rector of the Università degli Studi di Napoli "L'Orientale and he being duly authorized thereto, having its principal place of business at Palazzo Du Mesnil, Via Partenope 10/A, Napoli.

(hereinafter referred to as "_UNIOR_")

and

DAR ES SALAAM UNIVERSITY COLLEGE OF EDUCATION (DUCE)

A university in Tanzania, herein represented by _Professor Stephen O. Maluka in his capacity as the Principal of the Dar Es Salaam University College of Education and he being duly authorized thereto, having its principal place of business at Taifa Road, Temeke-Dar es Salaam, P.O BOX 2329

(Hereinafter referred to as "DUCE")

(collectively hereinafter referred to as the "Parties" and individually as the "Party")

Recognising:

- that cultural and scientific interaction is indispensable to institutions of higher education in developing their educational and research activities, and
- that institutions of higher education are enriched by international collaboration: the named institutions hereby record their understanding.

ARTICLE I

The purpose of this Memorandum of Understanding is to develop and carry out collaborative activities within areas of common interest of the named institutions based on the principle of mutual benefit and expresses the interest of both Parties.

The Università degli Studi di Napoli "L'Orientale and the Dar es Salaam University College of Education (DUCE) wish to enter into this Memorandum of Understanding (hereinafter referred to as "MoU") in order to promote and enable collaboration for joint educational, cultural interactions, training and research purposes.

Scientific and administrative coordinators shall be named by each Party to serve as liaisons for implementing this MoU. All activities conducted under the auspices of this MoU must have the endorsement of the coordinators. Coordinators shall notify their counterparts should a new person be named to the position.

ARTICLE II

The scope of collaboration on academic and research activities in this Memorandum of Understanding can include, but are not limited to, the following categories:

- 1. Exchange of staff; faculty, researchers and students.
- 2. Research and teaching collaboration in the areas of mutual interest to both parties
- 3. Joint scientific publications
- 4. Exchange of academic materials made available by both parties
- 5. Organisation of symposia, conferences, co-teaching, short courses and meetings on research issues of mutual interest.

ARTICLE III

To implement the aims and purposes expressed in ARTICLES I and II the following is mutually understood and agreed:

 Development of a specific project taking place within the scope of this Memorandum of Understanding shall take the form of a separate collaboration agreement which will in detail outline key responsible people, sources of funding, and specific collaborative activities. The agreement(s) will be in conformity with the provisions of this MoU.

- 2. The final approval of any project will be dependent upon the availability of guaranteed support funds.
- 3. Progress of work of any separate agreement under the Memorandum of Understanding will be reviewed and approved by designated responsible people of both parties.
- 4. Neither Università degli Studi di Napoli "L'Orientale nor Dar Es Salaam University College of Education shall be held responsible for any liability whatsoever; furthermore, neither party shall be required to purchase any insurance against loss or damage to any personal property to which this Memorandum of Understanding relates. Special arrangements, such as liability and accident insurance for incoming and outgoing students, may be considered for specific projects as outlined in paragraph (1) above. Except as specified in the agreement for implementation, each party shall consider its own arrangements.
- 5. Based on the principles of mutual respect and mutual benefit, the parties will protect each other's reputation and support each other's programmes and work.
- 6. This Memorandum of Understanding does not intend to create legally binding collaborations.
- 7. In the event of any-dispute arising between the two parties in connection with this MoU, the parties shall forthwith meet in good faith to attempt to resolve the dispute amicably through negotiation, consultation or diplomatic channels. If smicable settlement cannot be achieved within 60 days from the date of dispute or difference arose, this MoU shall stand terminated without any requirement for any formalities.
- 8 Each party shall have ownership rights to the intellectual property produced and achieved by that party and its employees in the course of implementing this MoU. When parties have jointly contributed to the development of intellectual property a joint ownership agreement shall be entered into between parties.
- 9. The joint language of collaboration will be English.

ARTICLE IV

Duration of the Memorandum of Understanding:

This Memorandum of Understanding will come into effect on the last date of signing and shall be effective for a period of five years. Thereafter it will be reviewed and can be amended or renewed as agreed by both parties. Amendments to the Memorandum

of Understanding can take place at any time by mutual agreement. Activities that are in progress after the termination notice of the agreement must be completed.

Either party may terminate the MoU by written notice submitted at least 90 days in advance of the next academic semester. The termination of the Memorandum of Understanding does not affect the validity of any separate collaboration agreements between the parties.
